Everyone has a responsibility for fire safety but your workplace will have a designated person - referred to as the responsible person - who has overall management responsibility for fire safety and compliance with fire safety regulations in your workplace.


In a residential care setting the responsible person will usually be the registered care home manager or owner, but in a large care home it could be someone who has a dedicated fire safety compliance role.

Additional trained staff, referred to as Fire Wardens or Fire Marshals, may be trained to carry out fire safety duties and checks.

**The Responsible Person**  
The responsible person is the person who has overall local responsibility for fire safety and compliance with fire safety regulations in your workplace.

The training identifies fire safety concerns and outlines measures that apply in adult residential care settings.
