### Responding to Extremism

Notice, Check, Share is a good process to keep in mind when fulfilling your safeguarding duty.

Click on each stage to find out more information.

- NOTICE**  
Be aware of the vulnerabilities that can lead to radicalisation and notice the signs of changing behaviour and attitudes which can become a cause for concern.
- CHECK**  
Check your concerns. Seek out a second opinion from your manager and/or designated safeguarding lead, in line with your safeguarding policy.
- SHARE**  
If decided by senior staff, share your concerns with the student and those who can help (e.g. Channel). Any response to the young person must be proportionate to the risk.

Our online Prevent duty awareness training explains the main points of the Prevent duty and the measures that schools and childcare providers must take in order to comply with it. Examples and scenarios will make you aware of the indicators that a child may be vulnerable to radicalisation and what to do if you believe a child is at risk.

For employers, the training provides an easy way to ensure that they comply with the legal responsibilities under **Section 26 of the Counter-Terrorism and Security Act 2015**.
