Risks, hazards and duties

If you are an employee, or you work under the control of someone else, you have a legal duty to take reasonable care of yourself and others who may be affected by your actions.

You must co-operate with your employer to enable them to comply with their health and safety duties and responsibilities.

The law says that you must:

- ◆ Report any safety hazard that you identify to your employer.
- ◆ Use the equipment and safety devices supplied to you properly and in accordance with any training and instructions - unless you think that this would be unsafe.
- ◆ If you think a safety device is unsafe, you should seek further instructions before continuing.
