It is important to understand that the Bribery Act applies worldwide.

This means that someone can be prosecuted in the UK for offering or receiving a bribe even if the actions took place overseas, provided that the person has a **close connection** with the UK.

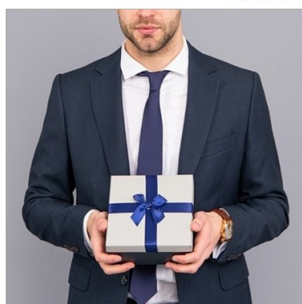
The offence of bribing

Bribing is committed where a bribe is offered or given with the intention of someone doing something improperly, or where the bribe is a reward for having already done something improperly.

The bribe does not have to be offered directly - it can be offered through a third party. This is still an offence.
