Employer and Employee Responsibilities

The responsible person has to take measures to prevent a fire from starting and to prevent anyone in a building from being harmed if a fire breaks out. An essential task is for a competent person to carry out a fire safety risk assessment so that:

- ♦ The fire hazards in the building can be identified.
- ♦ The risk of those hazards causing harm can be eliminated or reduced to as low as reasonably practicable.
- ♦ Physical fire precautions and management arrangements can be put in place to ensure the safety of people in your building if a fire does start.

The 5 steps in a fire risk assessment are shown opposite.

Evacuation Strategies

Single stage evacuation

A single stage evacuation strategy is appropriate for residents and others who fall predominantly into the independent category. That is, where it is reasonable to expect that all people in the building can, and will, immediately evacuate the premises and go outside to a place of total safety without assistance.
