Legislation

Part of Modern Slavery Human Trafficking Unit's work relates to the National Referral Mechanism or NRM.

This was introduced in 2009 and applies across the UK.

The NRM is used to identify victims of human trafficking or modern slavery and ensure they receive the appropriate support. The NRM is also a mechanism through which data is collected about victims of modern slavery and human trafficking.
