- ◆ Children forced to marry

Some companies, especially those who work in vulnerable sectors such as clothing and electronics, may worry about being completely open about their supply chains.

It is important to understand that it is in everyone's interest that companies have an honest and transparent view of their supply chains. Where slavery does exist in the supply chain, it is far better to be open about it and tell the world what is being done about it.

Companies should work collaboratively to reduce the risks of slavery. For example, they can work with civil society, other companies, suppliers or investors.
