The responsible person must provide the local fire and rescue service with the details necessary to access the secure information box.

The fire and rescue service must be informed as soon as practicable if there are any changes to these details.

Our Fire Safety England Regulations 2022 course explains the purpose of the Regulations and the role they play in protecting people in domestic premises. The Regulations apply to all buildings in England that comprise two or more domestic premises. The Regulations do not apply in Wales, Scotland and Northern Ireland.

The course will make you aware of the need for the Regulations and the key duties placed on owners and managers of multi-occupied residential buildings. This training is suitable for landlords, business owners or building managers and also for those responsible for inspecting fire doors.

The approximate duration of this training is 1 hour.
